I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "Releasees" defined herein; and that there may be other risks either not known to me or not readily foreseeable at this time related to the Activity; and that I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activity. I hereby release, discharge, and covenant not to sue EXTREME PAINTBALL (Telford Enterprises LLC), its respective administrators, members, owners, managers, directors, agents, officers, volunteers and employees, other participants, any sponsors, advertisers, and/or the owners and/or lessors of premises on which the Activity takes place, (each a "Releasee" and collectively the "Releasees" herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each Releasee from any loss, liability, damage, or cost, if any, which may incur as the result of such claim.
